THIS FIRST MODIFICATION OF AGREEMENT (hereinafter "First Modification") is by and between the **CITY OF PLANO, TEXAS**, a home-rule municipal corporation (hereinafter "Plano"), acting by and through its City Manager or his designee, and **THE UNIVERSITY OF TEXAS AT DALLAS, SCHOOL OF ECONOMICS, POLITICAL AND POLICY SCIENCES** (hereinafter "University"). Plano and University are sometimes collectively referred to as "Parties."

WITNESSETH:

WHEREAS, Plano and University entered into an Interlocal Agreement on July 29, 2020 (hereinafter "Agreement") for University to provide courses in Leadership, Management, Public Affairs, Government, and Diversity and Inclusion (hereinafter "Services") to Plano employees with total annual compensation not to exceed amount of \$35,000.00; and

WHEREAS, City and University desire to amend such Agreement to revise the University's contact information in Section VII (Notice) of the Agreement.

NOW THEREFORE, the Agreement is incorporated herein as if written word for word. Except as provided below, all other terms and conditions of the Agreement shall remain unchanged and shall remain in full force and effect. In the event of any conflict or inconsistency between the provisions set forth in this First Modification and the Agreement, priority of interpretation shall be in the following order: First Modification, Agreement. In consideration of the foregoing, and for other good and valuable consideration, the Parties hereto agree as follows:

Beginning on the effective date of this First Modification and continuing through the remaining term of the Agreement, the University's contact information in **Section VII. NOTICE** is hereby modified to read in its entirety as follows:
