#### Legislative and Legal Landscape


- Proposed Legislation




### Calls for Service by Month and Year






### Properties with 4 or More Calls For Service in 2020

# PD Short-Term Rental Data July 1, 2020 – Sept 30, 2020 (Q3)

- There were 38 CFS in the 3<sup>rd</sup> quarter of 2020
- The CFS involved 16 properties
- 4 properties involved 21 (55%) CFS



### Reported Noise Complaint Incidents July 1, 2020 – Sept 30, 2020 (Q3)

- There were 866 noise complaint incidents reported in Plano
- Of those 866 incidents, 21 (2.4%) occurred at STR locations

- There are currently four STR properties that have been designated as POP projects
- Officers are working with the owners, managers, neighbors, and HOAs to resolve the problems


