

An Ordinance of the City of Plano, Texas, repealing the 1993 City of Plano Storm Drainage Design Manual adopted by Ordinance No. 93-6-11 and replacing it with an updated Stormwater Design Manual, Guidelines for Design of Drainage Facilities of August, 2020 and providing a severability clause, a penalty clause, a repealer clause, a publication clause, and an effective date

WHEREAS, on June 14, 1993, the City Council of the City of Plano enacted Ordinance No. 93-6-11 to adopt the 1993 City of Plano Storm Drainage Design Manual (the "1993 Manual") and the City enacted earlier ordinances to adopt previous manuals by Ordinance No. 81- 8-7 and Ordinance No. 79-4-10; and

WHEREAS, pursuant to instructions and authorization of the Director of Engineering, the Engineering Division has prepared and submitted for consideration a revised manual entitled Stormwater Design Manual, Guidelines for Design of Drainage Facilities, August 2020 (the "2020 Manual"); and

WHEREAS, staff recommends repealing the 1993 Manual adopted by Ordinance No. 93-6-11 and replacing it with the attached 2020 Manual; and

WHEREAS, upon full review of the 2020 Manual, the City Council hereby finds that the provisions thereof are proper and are necessary to protect and promote the health, safety, and general welfare of the City of Plano and its citizens, and that such Manual should be adopted and the regulations thereof applied to all construction and development within the City, effective January 18, 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PLANO, TEXAS, THAT:

Section I. In order to promote the health, safety and general welfare of the City of Plano and its citizens, the 1993 Manual adopted by Ordinance No. 93-6-11 is hereby repealed in its entirety and replaced with the 2020 Manual.

Section II. The Director of Engineering may correct scrivener's errors in the 2020 Manual without approval of the City Council.

Section III. All provisions of the Code of Ordinances of the City of Plano, codified or uncoded, in conflict with the provisions of this Ordinance are hereby repealed, and all other provisions of the Code of Ordinances of the City of Plano, codified or uncoded, not in conflict with the provisions of this Ordinance shall remain in full force and effect.

Section IV. Any violation of the provisions or terms of this ordinance or the Stormwater Design Manual, Guidelines for Design of Drainage Facilities of August, 2020, by any person, firm or corporation shall be a misdemeanor offense and shall be

subject to a fine in accordance with Section 1-4(a) of the City Code of Ordinances for each offense. Every day a violation continues shall constitute a separate offense.

Section V. It is the intention of the City Council that this Ordinance, and every provision thereof, shall be considered severable and the invalidity or unconstitutionality of any section, clause, provision or portion of this Ordinance shall not affect the validity or constitutionality of any other portion of this Ordinance.

Section VI. This Ordinance shall become effective immediately upon its passage and publication as provided by law.
