Initiative Petition Report re: A proposed ordinance repealing an ordinance of necessity; limiting the city's eminent domain authority; establishing additional pre-requisites, burdens of proof, and standards for the use of eminent domain and protection of property rights. (Item II)

City Secretary Henderson provided the report and advised the petition was non-compliant and failed to meet the minimum signatures required. City Attorney Mims discussed legal issues with the proposed ordinance.
