Public Hearing and adoption of Ordinance No. 2021-9-8: as requested in Zoning Case 2021-014 to amend the Comprehensive Zoning Ordinance of the City, Ordinance No. 2015-5-2, as heretofore amended, so as to amend Planned Development-195-Corridor Commercial on 8.0 acres of land located on the south side of Park Boulevard, 385 feet east of Alma Drive, in the City of Plano, Collin County, Texas, to allow car wash as a permitted use; directing a change accordingly in the official zoning map of the City; and providing a penalty clause, a repealer clause, a savings clause, a severability clause, a publication clause, and an effective date. Applicant: Park-Alma Plano Venture No. One, LP (Regular Item "4")

Mayor Muns opened the public hearing. Derek Evans, applicant, spoke to the project. John Stafford spoke to possible environmental issues. Bill Lisle spoke in support of the project. Mayor Muns closed the public hearing.

Upon a motion made by Council Member Smith seconded by Council Member Ricciardelli, the Council voted 7-1, with Mayor Pro Tem Prince in opposition, to amend Planned Development-195-Corridor Commercial on 8.0 acres of land located on the south side of Park Boulevard, 385 feet east of Alma Drive, in the City of Plano, Collin County, Texas, to allow car wash as a permitted use; directing a change accordingly in the official zoning map of the City; as requested in Zoning Case 2021-014; with the stipulation of a landscape screen installed in the southeast corner of the property; and further to adopt Ordinance No. 2021-9-8.

Ordinance No. 2021-9-9: To approve and adopt the Operating Budget and setting the appropriations for the fiscal year beginning October 1, 2021, and terminating September 30, 2022; and providing an effective date. (Public Hearings held on August 9, 2021 and August 14, 2021.) (Regular Item "5")

Upon a motion made by Mayor Pro Tem Prince and seconded by Council Member Williams, the Council voted 8-0 to approve and adopt the Operating Budget and setting the appropriations for the fiscal year beginning October 1, 2021, and terminating September 30, 2022; and further to adopt Ordinance No. 2021-9-9.

Ordinance No. 2021-9-10: To approve and adopt the Community Investment Program and setting the appropriations for the fiscal year beginning October 1, 2021, and ending September 30, 2022; and providing an effective date. (Public Hearings held on August 9, 2021 and August 14, 2021.) (Regular Item "6")

Upon a motion made by Council Member Williams and seconded by Council Member Grady, the Council voted 8-0 to approve and adopt the Community Investment Program and setting the appropriations for the fiscal year beginning October 1, 2021, and ending September 30, 2022; and further to adopt Ordinance No. 2021-9-10.

Public Hearing on the proposed tax rate of \$0.4465 per \$100 of taxable value for Fiscal Year 2021-22. (Regular Item "7")

Mayor Muns opened the public hearing. No one requested to speak. Mayor Muns closed the public hearing.

Ordinance No. 2021-9-11: To approve and adopt the Tax Rate for the fiscal year beginning October 1, 2021 and terminating September 30, 2022, and providing an effective date. (Public Hearing is being held on September 13, 2021 prior to the adoption of this Ordinance.) (Regular Item "8")

Upon a motion made by Council Member Williams and seconded by Council Member Ricciardelli, the Council voted 8-0 to approve and adopt the Tax Rate for the fiscal year beginning October 1, 2021 and terminating September 30, 2022; and further to adopt Ordinance No. 2021-9-11.

Ordinance No. 2021-9-12: To ratify the property tax revenue in the 2021-22 Budget as a result of the City receiving more revenues from property taxes in the 2021-22 Budget than in the previous fiscal year; and providing an effective date. (Public Hearing is being held on September 13, 2021 prior to the adoption of this Ordinance.) (Regular Item "9")

MOTION:

Upon a motion made by Mayor Pro Tem Prince and seconded by Council Member Holmer, the Council voted 8-0 to ratify the property tax revenue in the 2021-22 Budget as a result of the City receiving more revenues from property taxes in the 2021-22 Budget than in the previous fiscal year; and further to adopt Ordinance No. 2021-9-12.

City Manager Israelson acknowledged the loss of Public Works Director Jerry Cosgrove and expressed gratitude for all of his work and contributions to the city.
