WHEREAS, the Planning Department is responsible for developing plans, policies, and programs designed to guide the physical design and development in alignment with the vision and goals of the Comprehensive Plan; and

WHEREAS, the city has completed a variety of documents including guidelines used in the day-to-day review of development plans, policy documents used to review zoning change requests, and specialized studies or reports that were often the basis for updates to the city's comprehensive plan; and

WHEREAS, many parts of these documents dating from 1989 through 2008 are no longer relevant to meeting the city's current development goals, but are still adopted as official city policy or regulation, sometimes resulting in uncertainty when providing guidance to the development community and preparing staff recommendations for the Planning & Zoning Commission and/or City Council; and

WHEREAS, upon review and consideration of the associated planning policy documents, the Planning & Zoning Commission has determined the documents are suitable to be retired from active policy guidance; and

WHEREAS, at its meeting on April 24, 2022, the Heritage Commission recommended repeal of the Design Guidelines for Plano's Historic Areas adopted by Resolution No. 93-6-4(R); and

WHEREAS, at its meeting on May 16, 2022, the Planning & Zoning Commission recommended repeal of twenty planning documents adopted by Resolutions Nos. 89-2-5(R), 93-6-4(R), 95-7-16(R), 98-5-10(R), 98-8-1(R), 99-8-24(R), 2000-5-31(R), 2001-4-14(R), 2002-11-14(R), 2003-3-5(R), 2003-9-49(R), 2003-10-19(R), 2004-5-23(R), 2004-6-26(R), 2004-12-34(R), 2005-1-26(R), 2005-9-31(R), 2005-9-32(R), 2007-8-27(R), and 2008-8-14(R); and

WHEREAS, at its meeting on May 24, 2022, the Heritage Commission recommended repeal of an Infill Housing Study adopted by Resolution No. 95-7-16(R); and

WHEREAS, the City Council desires to repeal obsolete planning policy documents, studies, and neighborhood plans.
