

MARKET UPDATE

Interest rates rose an additional 0.25% in quarter 3. The average 2-year Treasury security yields for April, May, and June were 4.02%, 4.13% and 4.64%, respectively. The City's portfolio yield in June was 2.71%. The Federal Open Market Committee (FOMC) increased rates once in the 3rd quarter of FY22, up to the 5.00%-5.25% range, in response to inflation concerns. The market is split between another rate hike in September or a pause.

ECONOMY UPDATE

Consumer Confidence- Consumer confidence rose in July 2023 to its highest level since July 2021, reflecting pops in both current conditions and expectations," said Dana Peterson, Chief Economist at The Conference Board. "Headline confidence appears to have broken out of the sideways trend that prevailed for much of the last year. Greater confidence was evident across all age groups, and among both consumers earning incomes less than \$50,000 and those making more than \$100,000. (The Conference Board: Consumer Confidence Survey)

GDP- Real gross domestic product (GDP) increased at an annual rate of 2.0 percent in the first quarter of 2023, according to the "third" estimate. In the fourth quarter of 2022, real GDP increased 2.6 percent. The GDP estimate for the first quarter was revised up 0.7 percentage point from the "second" estimate, primarily reflecting upward revisions to exports and consumer spending. The increase in the first quarter primarily reflected an increase in consumer spending that was partly offset by a decrease in inventory investment.(Bureau of Economic Analysis June 29, 2023 Release)

Labor Market – Total nonfarm payroll employment increased by 209,000 in June, and the unemployment rate changed little at 3.6 percent, the U.S. Bureau of Labor Statistics reported today. Employment continued to trend up in government, health care, social assistance, and construction. (BLS:) Employment Situation– June 2023)

CASH MANAGEMENT SUMMARY

During the 3rd quarter of FY22, the City had \$13 million in agency bonds and \$25.84 million in municipal bonds mature or be called. Purchases included \$5 million in agency bonds and \$39.65 million in municipal bonds. Primarily due to the 2023 debt issuance, revenues exceeded expenses creating a \$14.1 million positive book value adjustment on the portfolio. Therefore, the ending portfolio book value went from \$777.2 million at 3/31/2023 to \$791.4 million at 6/30/23.

Our average dollar-weighted maturity is currently 1.3 years (15.61 months), so we are within our maximum maturity of 2.5 years allowed by the City's investment policy.

Recent indicators suggest that economic activity has continued to expand at a modest pace. Job gains have been robust in recent months, and the unemployment rate has remained low. Inflation remains elevated.

The U.S. banking system is sound and resilient. Tighter credit conditions for households and businesses are likely to weigh on economic activity, hiring, and inflation. The extent of these effects remains uncertain. The Committee remains highly attentive to inflation risks.

The Committee seeks to achieve maximum employment and inflation at the rate of 2 percent over the longer run. In support of these goals, the Committee decided to maintain the target range for the federal funds rate at 5 to 5-1/4 percent. Holding the target range steady at this meeting allows the Committee to assess additional information and its implications for monetary policy. In determining the extent of additional policy firming that may be appropriate to return inflation to 2 percent over time, the Committee will take into account the cumulative tightening of monetary policy, the lags with which monetary policy affects economic activity and inflation, and economic and financial developments. In addition, the Committee will continue reducing its holdings of Treasury securities and agency debt and agency mortgage-backed securities, as described in its previously announced plans. The Committee is strongly committed to returning inflation to its 2 percent objective.

In assessing the appropriate stance of monetary policy, the Committee will continue to monitor the implications of incoming information for the economic outlook. The Committee would be prepared to adjust the stance of monetary policy as appropriate if risks emerge that could impede the attainment of the Committee's goals. The Committee's assessments will take into account a wide range of information, including readings on labor market conditions, inflation pressures and inflation expectations, and financial and international developments.






US Treasury Historical Yields




Treasury Yield Curve




Benchmark: 2 Year Treasury vs Plano Portfolio Yield



S&P 500




Portfolio Composition 6/30/23




