#### **TDHCA Housing Tax Credit (HTC) Application Timeline**

Deadline	Action
November 9, 2023	TDHCA will finalize the 2024 Qualified Allocation Plan (QAP)
December 1, 2023	HTC Application Online
January 1, 2024	HTC Application Acceptance Period Begins
March 1, 2024	HTC Applications Due – <i>Including</i> Resolutions for Local Government  Support
June 2024	TDHCA Public Comment Period on Submitted Applications
July 2024	Final HTC Awards Made



#### **City Council Housing Tax Credit Options**

- 1. Keep the 2022 HTC Resolution Application process with modifications, if needed, based on the TDHCA Qualified Allocation Plan (QAP);
- Accept all recommendations provided by the HTC Consultant; or
- 3. A combination of existing process, consultant recommendations and/or additional City Council direction.

Proposed development's zoning at time of HTC Resolution Application submission is not considered in the overall application review

No change recommended

Additional points/consideration based on whether is HTC applicant is a local developer is not provided

#### **HTC Consultant Recommendation**

#### **Overarching Application Considerations Continued**

Additional points/consideration based on the Property Management Company being local is not provided

Consider additional points/ consideration based on the Property Management Company being local

HTC Applications meeting the requirements to receive a Resolution of Support are provided a City Commitment of \$500

No change recommended

Community support letters are required

## **2022 HTC Application**(Last Council Approved Process)

#### **HTC Consultant Recommendation**

#### **HTC Resolution Application Threshold Question Amendments**

Question 2. Is the proposed development located with a half-mile (0.50) walking distance of DART transportation (current or developing public transportation route); or is the proposed development located in a high opportunity area?

Question 2. Is the proposed development located with a half-mile (0.50) walking distance of DART transportation (current or developing public transportation route)

**Question 3.** Is the proposed development located in a high opportunity area?

Does the proposed development have at least **20**% market rate units?

Does the proposed development have at least 10% market rate units?

February 12, 2024	City Council Review of HTC Resolution Applications
