Council Member Williams offered an amending motion, seconded by Council Member Ricciardelli, to additionally amend Section 15.2100.2 B to reflect "declared disasters by the City of Plano that create a need for temporary housing, until such time the disaster status is rescinded, or City Council rescinds such need for housing." Council voted 5-3, with Mayor Muns, Mayor Pro Tem Prince, and Deputy Mayor Pro Tem Tu in opposition, to amend the ordinance.

Council addressed the first motion, voting 7-1, with Council Member Williams in opposition, to amend Article 8 (Definitions), Article 14 (Allowed Uses and Use Classifications), and Article 15 (Use-specific Regulations) of the Comprehensive Zoning Ordinance of the City, Ordinance No. 2015-5-2, as heretofore amended, to allow temporary emergency shelters during life-threatening weather events; as requested in Zoning Case 2023-023; and further to adopt Ordinance No. 2023-10-12 as amended.
