ACTION PLAN

In October 2024, the City of Plano anticipates receiving from the U.S. Department of Housing and Urban Development (HUD), \$1,557,300 in Community Development Block Grant (CDBG) funds and \$521,594 in HOME Investment Partnerships (HOME) funds. The City also anticipates receiving \$100,000 in CDBG program income and \$20,000 in HOME program income during the period of October 1, 2024 to September 30, 2025 (Grant Year 2024).

The purpose of the CDBG and HOME programs is to support and perform activities that primarily benefit low- and moderate-income persons. Total HUD funds in the amount of \$2,363,246 will be used to fund activities during Grant Year (GY) 2024. Included in this amount is \$134,974 of previously unallocated GY 2023 CDBG entitlement funds, and \$196,865 of previously unallocated GY 2023 HOME entitlement funds. An additional \$147,487 in GY 2024 CDBG and \$78,239 in GY 2024 HOME funds were not allocated by the Community Relations Commission (CRC) and will be used to fund activities during Grant Year 2024. Based on the goals and objectives of the City's HUD Consolidated Plan, the CRC has recommended the following CDBG and HOME activities:

TOTAL CDBG and HOME RECOMMENDED: \$2,363,246

It is estimated that at least 95% of all funds to be expended will benefit low- and moderate-income persons. None of the proposed CDBG and HOME activities are expected to directly or indirectly result in the displacement of persons. Should any displacement occur, the City has a plan to assist displaced persons that conforms to the Uniform Relocation Assistance and Real Property Acquisition Policies Act.

PROPOSED SUBSTANTIAL AMENDMENT TO THE 2019-2020 ACTION PLAN

They City of Plano proposes a substantial amendment to its 2019-2020 Action Plan for the use of the United States Department of Housing and Urban Development (HUD funds). The purpose of this amendment is for the additional use of Community Development Block Grant – Corona Virus (CDBG-CV) funds made available under the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) (Public Law No. 116-136).

Approximately \$865,000 in CDBG-CV funds, previously set-aside for rent and utility assistance remain unspent due to the reduction/elimination of need due to COVID-19. These funds must be expended by September 30, 2026, on eligible activities. CDBG-CV funds may be utilized on activities that:

- 1. Prevent, Prepare for or Respond (PPR) to Coronavirus;
- Do not result in a duplication of benefit (Duplication of benefit occurs when a person, household, business or other entity receives financial assistance from multiple sources for the same purpose and the total assistance is more than the total need); and
- 3. Meet underwriting criteria for special economic development activities.

These funds will be used in the current GY 2023-2024 and GY 2024-2025, to rehabilitate residential properties owned by non-profits operating as transitional living shelters located within Plano. There are seventeen residential properties owned and operated by six nonprofit organizations in Plano operating as transitional living facilities for Plano's unhoused children, women, and youth. The CDBG-CV funds would be used to rehabilitate these homes and assist them in becoming more energy efficient.

PUBLIC COMMENTS

A public comment period will be open from July 1, 2024 to July 30, 2024.
