- A Resolution of the City of Plano, Texas, authorizing a Substantial Amendment to the 2019-2020 Action Plan for the use of U.S. Department of Housing and Urban Development Community Development Block Grant funds; and providing an effective date.
- **WHEREAS,** the U.S. Department of Housing and Urban Development (HUD) requires local governments seeking federal assistance through the Community Development Block Grant (CDBG) to develop an annual Action Plan; and
- **WHEREAS,** on July 22, 2019, the City Council adopted Resolution No. 2019-7-7(R) approving activities and proposed use of funds set forth in the 2019-2020 Action Plan; and
- **WHEREAS**, on May 11, 2020, the City Council adopted Resolution No. 2020-5-5(R) approving activities and proposed use of the funds to respond to the COVID-19 Pandemic by allocating CDBG-CV funds to annual Action Plan activities; and
- **WHEREAS**, the City's Citizen Participation Plan, required by HUD, requires the approval of a substantial amendment when (1) changes are made to Consolidated Plan goals and objectives, (2) changes made to project budgets approved in the annual Action Plan exceed twenty-five percent (25%) of the project's approved budget, and (3) new activities are added to the approved annual Action Plan; and
- **WHEREAS**, the City's Citizen Participation Plan required by HUD details the public participation process when seeking a substantial amendment to the Consolidated Plan and annual Action Plans; and
- **WHEREAS**, in accordance with the Citizen Participation Plan and waivers made available by HUD, a public notice was published in the Plano Star Courier on June 30, 2024, a copy of which is attached hereto as Exhibit "A", informing the public of the proposed 2019-2020 Action Plan; and
- **WHEREAS,** the City Council held a public hearing on July 22, 2024 to receive public comments regarding the proposed amendment to 2019-2020 Action Plan; and
- **WHEREAS**, at the close of the public hearing, the City Council approves of the Substantial Amendment to the 2019-2020 Action Plan which is attached hereto as Exhibit "B" and the related activities and proposed uses of the funds.
- NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PLANO, TEXAS, THAT:
- **SECTION I.** The City Council adopts the Substantial Amendment to the 2019-2020 Action Plan which is attached hereto as Exhibit "B".

SECTION II. The adoption of the Substantial Amendment approves changes to the 2019-2020 Action Plan, and allocation of new HUD CDBG-CV funds to previously approved activities in the 2019-2020 Action Plan.

SECTION III. This Resolution shall become effective immediately upon its passage.
