Subject: Adoption of the 2024 International Codes with Amendments - Review

In mid-2024 and early 2025 the regional code committees of our North Texas Council of Governments (NCTCOG) reviewed the International Code Council's 2024 construction codes and the National Fire Prevention Association's 2023 National Electrical Code (NEC). The culmination of these efforts is summarized in the attached letter from The North Central Texas Council of Governments with their recommendation for code adoption. Plano's Building Standards Commission (BSC) subsequently held four meetings this year to review these code amendments and receive stakeholder input. Meeting minutes are attached from each BSC hearing. As a result, the BSC unanimously recommends the 2024 International codes and the 2023 NEC with code amendments to the City Council for the June 9, 2025, meeting with an effective enforcement date of August 1, 2025. The recommended codes with amendments are:



SUBJECT: 2024 International Codes and Regional Code Amendments for North Central Texas

The North Central Texas Council of Governments (NCTCOG) Executive Board, upon recommendation of the Regional Codes Coordinating Committee (RCCC) and its Advisory Boards, endorsed the most recent regional amendments to several of the 2024 International Codes on March 27, 2025. The Executive Board encourages your jurisdiction to adopt the following 2024 International Codes and Regional Amendments:

- International Building Code
- International Energy Conservation Code
- International Fuel Gas Code
- International Mechanical Code
- International Plumbing Code

- International Residential Code
- International Swimming Pool and Spa Code
- 2023 National Electric Code (approved August 2023)

NCTCOG's RCCC recommends adopting the above-listed codes with no local amendments, other than the regional amendments, as expeditiously as possible. The 2024 International Fire Code (IFC) with recommended regional amendments will be brought forward for regional endorsement in the very near future. The ultimate goal is regional uniformity of building codes for the North Central Texas region. Achieving the goal of standardization of building codes across the region will result in positive economic impacts and other benefits for municipalities, contractors, architects, builders, and manufacturers.

Chairperson Ed Acklin called the meeting to order at 2:05 p.m. Tuesday, April 15, 2025, in the Training Room A. A quorum was present and notice of the meeting had been posted for the time and manner required by law. The following matters were discussed.

Chairperson Ed Acklin admitted all documents and testimony given into the official Building Standards Commission record.

Commission Member Daryl Bowen made a motion to approve the minutes from March 18, 2025. Commission Member Mark Malouf seconded the motion. The Commission voted 8-0 to approve the minutes from March 18, 2025.

3. Discussion and consideration of applicant's request to use alternate materials or construction methods for NSF-50 Certified Spa Chiller in compliance with requirements Section 309.2 Treatment and circulation system equipment of the International Swimming Pool and Spa Code, which is codified in Chapter 6, Building and Regulations, Article XXIII. Building Code of the Code of Ordinances of the City of Plano, Texas. Applicant: Brent Merritt on behalf of EoS Fitness Spas, Property Address: 600 W 15TH Street, Suite B, Plano, Texas 75074.

Selso Mata, Chief Building Official, presented the alternate method or construction material of Section 309.2 Treatment and circulation system equipment of the International Swimming Pool and Spa code. Mr. Mata testified to the history of the project and request for additional equipment specifications.

Calvin Young, Environmental Health Manager, spoke to the code requirements for inspection of commercial swimming pools and spas. Mr. Young testified requests of the Applicant and Contractor to provide equipment specifications and have not received adequate documentation stating the proposed NSF-50 equipment is approved for commercial pool usage.

Mr. Young answered questions from the Commission on what the purpose and standards of chiller testing. Mr. Young testified there is not currently an approved NSF-50 approved for commercial pool usage, however a person could request third party testing of the equipment.

Brent Merritt, Cody Pools, testified there are no certified NSF-50 chillers on the market at this time. Mr. Merritt is requesting that the Commission allow them to use NSF-50 as they have installed seven of the NSF-50 systems in southern states including in Texas.

Mr. Merritt answered questions from the Commission.

John Davis, general contractor, testified they have installed the NSF-50 chillers at other facilities in other cities without issue. Mr. Davis testified the codes have not caught up with cold plunge trends.

Mr. Davis answered questions from the Commission. Mr. Merritt and Mr. Davis are not aware of any third-party testing performed on the NSF-50 chiller.

Sean Sante, Representative for EoS Fitness, testified the NSF-50 chillers have not been installed in other Plano EoS Fitness locations.

Ileana Fernandes, Sr. Assistant City Attorney, stated the Commission can only grant or deny an alternate method but does not have the authority to grant variances.

Mr. Young presented the Aquacal website showing the NSF-50 product specifications which states the chiller has not been approved for commercial use.

Commission Member Elle Cole arrived at the meeting at 2:25 p.m. but did not vote on this item.

Chairperson Ed Acklin closed the floor to public comment.

Commission Member Ed Acklin made a motion to deny the request to use alternate materials or construction methods for Section 309.2 Treatment and circulation system equipment of the International Swimming Pool and Spa Code. Commission Member Will Clay seconded the motion. The Commission voted 7-1 in favor of the motion, with John Egan voting in opposition.
